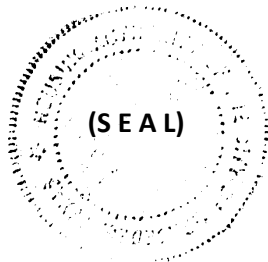
PUBLIC NOTICE REGULAR BOARD AGENDA June 25, 2024
